<p>Article 1</p>	<p>1. This bylaw is called the Aqaba Port Service Charges Regulations for the year 2009 issued in accordance with the decision of the Board of Commissioners of the Aqaba Special Economic Zone Authority No. (510/2008) dated 11/18/2008.</p>		
	<p>2. These regulations and the attached schedules (1, 2, 3, 4) shall be effective as of the first day of March of the year 2009.</p>		
	<p>3. As of the first day of January of 2010, Schedule No. (5) shall be applied instead of Table No. (3) attached to this regulation, and Table No. (6) shall be applied instead of Table No. (4) attached to this bylaw. As for Tables (1) and (2) attached to this bylaw, their implementation will continue in accordance with the provisions of these regulations.</p>		
	<p>4. This regulation applies to port services that are provided at the port</p>		
	<p>5. No provision in these regulations shall affect any law or regulation related to customs duties or any other fees or taxes imposed or applied in the Aqaba Special Economic Zone, or on any order or decision issued and directed legally in accordance with the provisions of that law or regulation</p>		
	<p>6. The provisions of these regulations shall apply to all agreements concluded between the Ports Corporation (the Corporation) and its clients regarding the services provided by the Corporation, unless otherwise agreed upon in writing between the parties to these agreements and with the approval of the ADC.</p>		
	<p>7. 7 - The provisions of this regulation do not apply to the services provided by the Aqaba Container Port Company and the Aqaba Port Company for Maritime Services, as these services are subject to special allowances issued by the authority.</p>		
	<p>8. The tables attached to this bylaw shall be considered an integral part of it and to be read with it as a single unit.</p>		
	<p>9. All allowances mentioned in the tables attached hereto are in Jordanian dinars.</p>

<p>Article 3</p>	<ol style="list-style-type: none"> 1. The Corporation works to provide all port services in accordance with its appreciation and best capabilities, by using devices, equipment, machinery, materials, labor and facilities of appropriate quality for its assigned use. 2. The Corporation shall not be held responsible for any damages or breakdowns that may result from the operations of suspending, suspending, or delaying the port services it provides as a result of the force majeure. 3. The use of the port by ships and customers is considered an acceptance by them of the quality of port services, their allowances and all other conditions related to them. 4. The client is obliged to provide the institution with all the information and documents necessary to provide its services at least (24) twenty-four hours before the scheduled date for the provision of services to ensure proper implementation of the services efficiently and effectively and for the purposes of issuing financial claims for the services provided, and in the event that such information and documents are not received within the specified time Or if the information and documents are incomplete, the Corporation has the right to stop or postpone the implementation of the required services until the required information and documents are received and / or completed by the client. 5. The Corporation reserves the right to view all documents related to ships, merchandise, passengers and vehicles in order to implement the services it provides and calculate the fees for port services resulting from it according to these regulations.
<p>Article 4</p>	<p>The Corporation provides the following port services:</p> <ol style="list-style-type: none"> 1. Ship boarding services. 2. Water supply services for ships and transport of waste from ships in the port. 3. Goods loading, unloading, handling and storage services. 4. Goods inventory, inventory, inspection and weighing services. 5. Trucking and weighing services. 6. Renting devices, equipment, machinery, vehicles, workers, and utilities necessary to provide port services. 7. Rescue, ambulance, firefighting and oil pollution services at the port and all related services. 8. Other port services related to ships, goods, passengers and vehicles in the port
<p>Article 5</p>	<ol style="list-style-type: none"> 1. The Corporation meets the fees for port services according to tables No. (1, 2, 3, 4) or tables No. (1, 2, 5, 6) according to the case and attached to these regulations, and these regulations or tables attached to them may be modified from time to time under Prior notice and after obtaining the approval of the authority, provided that the amended allowances apply after (90) ninety days from the date of their issuance.

	<ol style="list-style-type: none"> 2. All fees for port services specified under these regulations are in Jordanian dinars, and financial claims are paid in Jordanian dinars. 3. In the event that any merchandise or service request is received for which no text is stipulated in these regulations and the tables attached thereto, the Corporation has the right to collect the port services charges incurred by it by a decision of the Director General to be presented later by the Aqaba Development Company to the Board of Commissioners of the Aqaba Special Economic Zone Authority For approval. 4. The Corporation may conclude special agreements with its clients that include the collection of special allowances for the port services stipulated in the attached tables, in exchange for the commitment of customers to import or export specific quantities of goods during specific time periods or any other type of obligations provided that obtaining the prior approval of the authority on these Agreements, so that these agreements are submitted by the Aqaba Development Company to the Board of Commissioners of the Aqaba Special Economic Zone Authority for approval as a precondition for their enforcement.
<p style="text-align: center;">Article 6</p>	<ol style="list-style-type: none"> 1. Any port services allowances approved under special agreements between the Corporation and any third party prior to the enforcement of the provisions of these regulations are considered as if they were issued according to them. 2. For the purposes of paragraph (1) of this Article, allowances for port services that are fulfilled according to these special agreements shall remain in force and subject to the provisions of those agreements. 3. In the event that the term of the special agreements stipulated in Paragraph (1) of this Article expires and is not renewed, all provisions of these regulations and schedules attached thereto will be applied to the port services that will be provided to the parties to these agreements.
<p style="text-align: center;">Article 7</p>	<ol style="list-style-type: none"> 6. Goods imported in the name of His Majesty the King are exempt from port service charges. 7. It is not permissible to obtain more than one reduction on the handling services fees for a single consignment. 8. Imported or exported goods are exempt from storage service fees for the first (10) ten days from the date of storing all consignments or part thereof, whichever is more appropriate for the establishment, provided that the exemption period becomes for the first (7) days only after two years have passed since the issuance of this regulation. 9. Goods sold by public auctions are exempt from storage service fees for the first (10) ten days from the date of sale. 10. Goods shall be exempted from storage service fees by a decision of the Director General for the period in which the delivery of goods to their owners is delayed if it is proven that the establishment was the cause of that delay, provided that all procedures for withdrawing goods are in place.

	<p>11. Storage service fees are reduced by (50%) for goods that are destroyed in the port. This does not apply to goods that are imported damaged or rejected by the competent authorities.</p>
	<p>12. The service charges (cargo handling) for transit goods, which are collected from the cargo owner, shall be reduced by 40%.</p>
	<p>13. The shipping agent is granted a 7% reduction on the unloading and loading services fees due on the vessel he represents if he pays the full port service fees due within (10) days from the date of issuing the invoice.</p>
	<p>14. The handling service fees for imported and exported Qatari goods through the port shall be reduced by 25%.</p>
	<p>15. Granting a 20% reduction from the storage service allowance incurred by the mafins (garages) belonging to the shipping lines, provided that the shipping agent commits to reloading the mafia within a maximum of one month from the date of storage commencement.</p>
	<p>16. Granting a 50% reduction on the shipping service fees, provided that this reduction does not apply to the shipping agent.</p>
<p>Article 8</p>	<p>1. The process of mooring and docking of ships is considered complete from the time its anchors are cast into the sea or when the first rope of its ropes is attached to the dock or on the dock boundaries, respectively.</p>
	<p>2. The process of removing ships from the port is considered complete, starting from the time when its berths are lifted from the sea or when the last rope of their ropes is removed from the berth on which they berth respectively.</p>
	<p>3. All ship services are calculated on the basis of the registered existing load (GRT). In the event that the ship does not have a registered payload, the total load (GT) is used. The total existing tonnage registered for the two ships and / or the vessel and the aid, as appropriate.</p>
	<p>4. The port services for any vessel may not be provided unless it has a shipping agent who represents it at the port.</p>
	<p>5. The Corporation shall bear the marine service charges incurred by the ship in the event of changing its place of mooring or abandonment at the request of the Corporation. The shipping agent shall bear the costs of the maritime services incurred in the event of changing the location of the landing or mooring at the request of its agent or the captain of the ship or because of the low production of the ship or because of the large number of breakdowns provided that the establishment is not a reason for this.</p>
<p>Article 9</p>	<p>1. For the purposes of calculating port service charges, today's calculation starts from the first minute</p>
	<p>2. The shipping agent must present an irrevocable bank guarantee acceptable to the corporation and issued by an accredited Jordanian bank at the value to be determined by the institution or - if the bank guarantee cannot be provided - provide another financial guarantee acceptable to the corporation. The shipping agent is granted a grace</p>

	<p>period of (10 Days from the date of issuance of the invoice for the full payment of the claim owed by the vessel.</p> <p>- In the event that the shipping agent fails to pay the value of any claim within the aforementioned period of (10) days, the corporation is entitled to calculate a delay allowance at the rate of 9% annually of the value of the claim, so that the interest calculation begins after (10) days from the date of issuing the invoice until the date of full payment of the claim. . The Corporation also reserves its right to take all legal measures to preserve its rights, including the right to liquidate the bank guarantee or the financial guarantee after notifying the shipping agent, in the equivalent of the amounts due under unpaid claims in addition to any delay allowances due on these amounts in accordance with the provisions of this clause.</p> <p>3. The amounts collected by the institution, in excess or by mistake, shall be refunded to the clients within a period not exceeding (10) ten working days from the date on which the client informs the organization in writing of the amounts collected in excess or by mistake, with the approval of the director general.</p> <p>4. Without prejudice to the provisions of Clause (9/2) above, the Corporation may suspend or suspend the port services it provides in the event that the allowances due for these services are not paid within the specified period of payment.</p> <p>5. Without prejudice to the provisions of clause (9/2) above, it is not permitted to deliver goods to their owners before payment of the port services fees owed by them or providing an acceptable guarantee to the establishment.</p>						
<p>Article 10</p>	<p>1. The Corporation shall collect additional service allowances for any employment or service required by the ship or the goods or which the establishment considers necessary or necessary to provide port services, and these additional allowances shall be fulfilled in accordance with the allowances specified in Table No. (4) or (6), as required by the case attached to these regulations. Article 11	1. The customer is obligated to abide by the port requirements for public safety, security and environmental protection, and the customer shall bear any expenses borne by the institution resulting from his failure to comply with these requirements.
	2. The entry of dangerous goods to the port is subject to the prior approval of the institution and the competent authorities.
	3. The customer is responsible for providing the equipment and mechanisms necessary for unloading, loading, transporting and handling goods of sizes and / or weights in excess of the capabilities of the institution, provided that the establishment pre-approves its reception.
	4. Weight on the corporation's bunkers is mandatory for all types of trucks entering the port for the purpose of loading or unloading, with the exception of trucks that cannot be weighed on the bushings for technical reasons.
	5. The metric ton is the unit of fulfillment of the port services allowances specified in these regulations. It is obligatory to break the hundred kilograms in each policy to one hundred kilograms.
	6. For the purposes of determining the weight of the goods, the ship's load, port measurements, silo counters, or the load measurement report, which is better for the organization, is approved. The corporation has the right to investigate the validity of these weights by the methods it deems appropriate.
	7. If the customer requests that the goods be sorted according to their measurements, specifications, packaging, or repackaging, the establishment will do so at his expense according to the fees specified in tables No. (4) or (6) attached to these regulations as appropriate, provided that the customer provides the materials required for sorting and / Or packing and / or repackaging and obtaining the approval of the competent authorities.
	8. It is not allowed to store empty containers for more than one month in the port. The Corporation, after warning its owners, may dispose of it for its benefit or sell it in exchange for the services fees incurred by it and without any responsibility on the institution.
	9. The Corporation collects the port services fees for goods sold by public auction from the price sold by it after collecting the customs fees due on it.
	10. The fees of the workers and the working mechanisms necessary for unloading, loading and transporting the goods from the anchorage to the berth or vice versa according to schedules No. (4) or (6) attached to these bylaws, as required, are collected from the customer.
